UNESCO Information for All Programme (IFAP)

IFAP was established in 2001 as a flagship intergovernmental UNESCO programme for the purpose of assisting Member States in formulating and implementing balanced national policies of building inclusive knowledge societies. IFAP is based on inter-disciplinary, cross-sectoral and integrated approaches. Promotion of information literacy is one of the Programme's priority action lines. Other IFAP priorities are information preservation, information accessibility, linguistic diversity in cyberspace, information ethics and information for development.

Russian Committee for the UNESCO Information for All Programme

Russian IFAP Committee was established in 2000 under the Commission of the Russian Federation for UNESCO and the Ministry of Culture of the Russian Federation in compliance with recommendations of the Intergovernmental Council for the Information for All Programme to link it with Russia. The Committee provides assistance in implementing the Programme's ideas, goals, concepts and priority lines of actions at both national and international levels. Russian IFAP Committee members represent government agencies, educational, research, cultural and communication establishments, non-governmental organizations and private sector. The Committee contributes to the work of UNESCO and IFAP constitutional organs, promotes UNESCO information and communication policy in Russia and other CIS countries, ensures information exchanges with national and international agencies in other countries, and provides access to Russian-language information about global trends in building knowledge societies and UNESCO activities.

Russian IFAP Committee participates in the advancement of national and international policies and legislation in the fields of culture, education, communication and information for the purpose of building inclusive knowledge societies. It contributes to the preparation of analytic reports and elaboration of practical guidelines, to the establishment of the best practice centres and to the improvement of activities of various institutions within its competence.

Since its early days the Committee has been promoting media and information literacy, which resulted in over 30 workshops and seminars organized in different regions of Russia, two national and two international conferences held, a number of monographs, collections of scientific and analytical work, teaching aids published.

The International conference "Media and Information Literacy for Knowledge Societies" (Moscow, 2012) adopted an important international document – the

Moscow Declaration on Media and Information Literacy. Within the Russian presidency of the Intergovernmental Council for the UNESCO Information for All Programme the Committee initiated the adoption of a joint IFAP–IFLA Action Plan (2011) and the development of IFLA Media and Information Literacy Recommendations (2012), approved by the UNESCO General Conference in 2013.

Ladies and gentlemen,

I greet you at the first international UNESCO conference on Media and Information Literacy for Building Culture of Open Government in Khanty-Mansiysk.

Ugra and UNESCO are linked together by many years' partnership, joint initiatives and effective international projects, many of which have won renown and support in dozens of countries – suffice to mention the Save and Preserve international ecological action, the international IT forum, the UNESCO associated school conference, The Ob-Irtysk Basin: The Youth Studies and Preserves Natural and Cultural Heritage in the Regions of the World's Great Rivers, the international crafts festival of the indigenous peoples, and the formation of the Register of Intangible Heritage of the Ugra Peoples.

While implementing the communique signed in 2014 to summarize the Ugra Days at the UNESCO Headquarters, we have planned new fields of partnership topical both for experts and the public-at-large in Russia and worldwide: the preservation of indigenous languages, development of diversity in cyberspace, and the use of the latest tactics and technologies to attain these goals. World expert meetings on those topics in Paris and Khanty-Mansiysk promoted new Ugra-based projects, such as the establishment of a depository in 2015 on the platform of the Ob-Ugra Institute of Applied Research and Development. It aims to bring folklore materials into system, regulate their storage, and provide online public access to the intangible cultural heritage of the Ugra indigenous peoples.

This year, our international conference is dedicated to Media and Information Literacy for Building Culture of Open Government. A conference on this theme has never been convened yet. Last year, the 70th session of the UN General Assembly



adopted the 2030 Agenda for Sustainable Development, which envisages 17 goals and 169 related targets. It promotes dynamic international demand for development-oriented information, and systematized academic, expert and humanitarian dialogue and knowledge exchanges. International meetings on “information for development” to attain these goals are now topical and popular as never before. Every government’s work for sustainable development demands open governance, when the public-at-large, experts, public activists, the academic community and businesses are involved in decision-making and implementation. The search for the most efficient instruments of such public participation, exchange of the best practical patterns of forming the system of open regions and open government, public training to acquire media and information literacy, and efficient handling of relevant data are among the top applied priorities of this conference.

Our region is addressing these problems. Ugra has established the Open Region centre to form the culture of openness in state governance. Several educational projects are being implemented now on the basis of that centre, which also works to form pioneer approaches to information access, crowdsourcing development, and provision of dialogue venues for experts and the public-at-large. We work to put an end to digital inequality, train the population in the use of electronic services on the Electronic Citizen programme, and develop the websites of online libraries and museums and of Ugra civil society. There is a territorial geo-information system and a media school. We are interested in international experts’ knowledge and cooperation in every field of this work. I am confident that this conference will promote such contacts, and develop into a permanent and influential platform to elaborate new approaches to the formation of open government culture.

**Excellencies,
Ladies and Gentlemen,**

On behalf of the 26 Member States elected to the Council of UNESCO's Intergovernmental Information for All Programme (IFAP) and its subsidiary bodies, in my capacity as Chair of the IFAP Council, and on my own behalf, I would like to extend warm wishes to the organizers and participants in the international conference, "Media and Information Literacy for Building Culture of Open Government".

Nowadays, information and knowledge are the key sources of value addition today across all sectors and are increasingly a source of competitive and strategic advantage. Unless we have equitable access to relevant information and knowledge and unless they are effectively used, national and planetary-scale challenges such as addressing climate change and realizing the 2030 Sustainable Development Goals cannot be achieved. Clearly, information and knowledge are essential for effective decision-making and problem solving from the individual to societal level. Information and knowledge therefore represent powerful catalysts for mobilization and transformation.

Governments through their various departments and functions – education, scientific research, health services, economic and cultural industries, amongst others – have a central role in the provision of access to the public domain for all citizens.

Increasingly through open government and open data initiatives around the globe, we governments are adopting commitments at the policy level to making government information publicly accessible and also putting in place the necessary resources, using both offline and on-line platforms, including social media, to facilitate our citizens' access to the public domain.

The results of these efforts include more rapid innovation and the development of both for-profit and non-profit organizations who are now using this under-utilized public resource to create jobs, new services and benefits in sectors from transport to health. This mind shift is also supporting citizen engagement in government and enhanced transparency.

IFAP has been also contributing to the development and access to the public domain. In the Andean region of Latin America IFAP has worked with local governments to support their efforts to reach out to citizens by making information about the services that citizens were entitled to readily available on-line. This involved changing the mindsets of civil servants and government officials from one of hoarding to sharing public information. In addition, by supporting citizens to develop MIL skills and working with telecom service providers to establish Internet access points, citizens were empowered to engage with local government and exercise their rights and responsibilities.

Also in Latin America, IFAP's establishment of the Bibliotheca Virtual, a repository of the youth policies of 14 countries Latin American countries, has led to increased cooperation between governments as well as youth groups. Simply making these public resources accessible has led to policy innovations with countries learning from each other and benefitting from the experiences of their regional neighbours.

At the normative level through instruments such as the IFAP Code of Ethics for the Information Society and the Moscow Declaration on Media and Information Literacy for Knowledge Societies IFAP has been consistently bringing attention to the need for policies in these critical areas. The Internet universality principles adopted at UNESCO's 38th General Conference are also an endorsement of the importance of MIL and multi-stakeholder partnerships between governmental and various non-governmental actors.

Your conference marks another important stage in IFAP's journey to ensure that every person is able to access and utilize information and knowledge to reach their full potential and contribute to human development and peace. For, when knowledge is power, a mind is a terrible thing to waste. Against the backdrop of the sustainable development goals and the growing recognition that information and knowledge are the key sources of value addition, the reflections of this conference take on heightened importance and are a significant contribution to the global public policy debate.

I should like to express my sincere appreciation to the Government of the Khanty-Mansiysk Autonomous Okrug – Ugra (Russian Federation), the Russian National Committee for the UNESCO Information for All Programme, the Interregional Library Cooperation Centre (Russian Federation), the Federal Agency for Print and Mass Communications and UNESCO for making this event possible.
