In a world increasingly being shaped by digital technologies, the traditional guardian institutions (libraries, archives and museums) are challenged to keep pace with the rapid growth in information. They also face a new challenge — as technology advances the stability and lifespan of documents is considerably decreasing. If nothing is done, many important documents in electronic format will not survive or will become completely inaccessible within a very short time. The result will be a permanent loss to the collective memory of humankind. This challenge needs to be tackled urgently and the costs of preserving digital information should not be underestimated — these far exceed the preservation costs experienced to date with five millennia of traditional document.

IFAP was established by UNESCO to provide a framework for international cooperation and partnerships in building an inclusive information society. IFAP goal is to assist the development of national information policies framework.
